The center's soup kitchen serves 100-150 meals per day, six days per week. The food pantry provides healthy food and diapers to 150 households per week. The day shelter provides warmth and rest to the homeless. The resource center offers phone and mailing address access, toiletries, and winter gear, mental health referrals, and staff support. The immigrant integration program helps patrons apply for jobs, complete immigration paperwork and address barriers.
